

MEDICARE PROVIDER FEEDBACK TOWN HALL MEETING

September 12, 2005

2:00 - 4:00 PM EST

On September 12, 2005, the Centers for Medicare & Medicaid Services (CMS) will convene a Medicare Provider Feedback Town Hall meeting. **We encourage all individual providers, physicians and suppliers to participate in this exciting forum.** The meeting will provide the Agency with an open and public venue to interact with individual Medicare providers, physicians, and suppliers and obtain their opinions on a variety Medicare policy and operational issues. It will be held in CMS' auditorium located at 7500 Security Boulevard in Baltimore, Maryland and via teleconference.

This meeting is a valuable opportunity for the Medicare provider and supplier community to provide feedback on issues that are important to them. This feedback will be vital to the Agency as we strive to implement innovative strategies that integrate input from our Medicare providers and suppliers and incorporate their perceptions and opinions into our work.

The following topics will be discussed at the meeting:

- Minimizing standard paper remittance advice (SPR) notices and its effect on individual physicians and provider/supplier practices;
- Important information for individual physicians and providers/suppliers on CMS' implementation of the National Provider Identifier (NPI);
- Implementation of Medicare Contracting Reform and its impact on individual physicians and providers/suppliers;
- Discussion on the proposed rule for the 2006 physician fee schedule;
- Effect of a revised payment system for Ambulatory Surgical Center (ASC) facility services; and
- Individual perspectives from hospitals on how Medicare pays for new technologies.

CMS will provide a brief overview of each topic and provide an opportunity for meeting participants to provide feedback on the topics presented.

CMS may conduct follow-up meetings with registered participants to solicit additional opinions and/or clarify any issues that may arise during the September 12, 2005 meeting. The information gathered from the town hall and subsequent meetings will serve as feedback on CMS provider/supplier communication activities and related topics.
